## Short summary in response to House Resolution 936 of 2014 Diabetes in Pennsylvania: Prevention and Maintenance Programs

This is the sixth of a series of reports by the Joint State Government Commission (JSGC) written in response to House Resolution No. 936 of 2014. HR 936 provides for an ongoing study of the public health problem posed by diabetes in Pennsylvania and directs the JSGC, in collaboration with certain other state departments and agencies, to describe, evaluate, and make recommendations for the Commonwealth's response. This report describes the relevant programs run by the entities charged with implementing public health policy and with assisting persons with diabetes. The broad purposes of public health policies aimed at controlling diabetes and preventing the disease are "to reduce the incidence of diabetes, improve diabetes care, and control complications associated with diabetes" (HR No. 936 of 2014).

The introduction contains a general discussion of diabetes as a public health problem nationwide and in Pennsylvania and the latest available data regarding incidence and prevalence of diabetes, prediabetes, and obesity in the United States and in Pennsylvania.

The first chapter includes the definition and classification of diabetes mellitus.

The second chapter describes the current guidelines on diabetes medical care and prevention, developed by the ADA and other leading guidelinesetting organizations.

The third chapter lists the programs administered by the Department of Health, which is the lead agency on public health issues. These programs include the Diabetes Prevention Program (DPP), the Diabetes Self-Management Education and Support Program (DSMES), type 1 diabetes activities, and obesity prevention and wellness activities.

The fourth chapter covers the programs administered by the Department of Aging: the Health & Wellness Program, the Chronic Disease Self-Management Program, the Diabetes Self-Management Program, and PACE.

The fifth chapter outlines the diabetes-related activities of the Department of Human Services: Medical Assistance (Medicaid) and Community HealthChoices (CHC).

The sixth chapter covers YMCA's Diabetes Prevention Program.

The seventh chapter details diabetes-related activities of the Health Promotion Council (HCP).

The eighth chapter describes Latino Connection diabetes prevention and self-management program.

The report concludes with a list of recommendations aimed at increasing the awareness of diabetes and prediabetes, facilitating early diagnosis, improving access to care and quality of care, removing obstacles that impede timely and continuous diabetes treatment, and prioritizing patient-centered care.
